Addition to the by-law 03-01-2011 connection to municipal water mains

Article 1: Turn On/Off Requests

All requests for connection to the water system or the opening/closing of the water must be made in writing to the Municipality

Article 2: Turn On/Off Costs

The cost of opening or closing the water for a residence, between May 15th and October 15th of the same year, is \$50.00 payable to the municipality for each service. The owners' presence is required for any opening or closing.

All requests for opening or closing outside of these dates (Oct. 15th to May 15th of the following year) will be at a minimum charge of \$100.00 or \$100.00/hour whichever is greatest, payable to the Municipality, unless the request is deemed an emergency, at the discretion of the Municipal foreman.

Article 3: Connection Fees & Times

The fee for connection to the Municipality's main water line will be the actual costs incurred by the Municipality or a flat fee of \$500.00 one or the other, whichever is the greatest. Payment in full of the quoted price will be made to the Municipality of Otter Lake prior to the installation of any new water main connections. All water main installation hook ups will occur between May 15th and October 15th of the same year

Article 4: Water Service Connection

Only one ¾ inch service line connection, which shall not exceed 200 feet in length, will be made from the municipal main line to the primary residence of any given civic address within the Municipal water zone.

Article 5: Water Zone

The municipal water zone, for which the Municipality provides water, is describe as the village core and is shown as per the zoning map P2-01-03 of Otter Lake.

Article 6: Dwellings Serviced

Types of dwellings to be serviced with municipal water will be as per the municipal utilization codes for primary residences, cottages and businesses; types of residences not serviced by municipal water include but are not limited to: utilization codes 1200,

Article 7: Fines/Infractions

All work pertaining to the Municipality's water distribution system, including the turning on and off of the service, must be performed by the municipality with the appropriate approvals.

Any unauthorized work will be considered an infraction to this by-law and liable to fines in the amount of two hundred dollars (\$200) for a 1st offense, five hundred dollars (\$500) for a 2nd offense and seven hundred and fifty dollars (\$750) for every consequent offense for a physical person.

The fines in the case of a moral person shall be four hundred dollars (\$400) for 1st offense, one thousand dollars (\$1000) for a 2nd offense and one thousand five hundred dollars (\$1,500) for any consequent offense.

All fines are payable to the Municipality of Otter Lake plus applicable fees.

Article 8: The regulations will come into force in accordance with the law.
